Postgraduate Degree Programmes

At CEPMLP, our students have a choice of over 40 modules which are delivered by our full-time academics and global faculty. All full-time students start their studies with an intensive three week programme which covers the basic principles of law, economics, management, finance, production of petroleum and graduate research methodology before selecting their core and elective modules.

Specialist LLM (Master of Laws)

The specialist LLM programmes at CEPMLP are unique in the fact that they offer a conceptual education in both the regulatory framework, general and specific transactions and basic business skills combined with a specialised orientation provided by the wide range of electives. This flexibility allows the student to pursue their specific areas of interest through the specialised electives, whilst at the same time being provided with a theoretical underpinning via the core regulatory framework and international business law components of the LLM.



Natural Resource-Focused Business and Management

CEPMLP business and management degrees offer an insight into the relationships between the public and private sectors and the community at international and national levels. CEPMLP offers a wide range of modules contextualised for the energy and natural resources, enabling students to pursue a specific area of interest, while developing their skills and professional competence to excel in a sector where continuous innovation is crucial to productivity and growth.

MSc Energy Studies

This interdisciplinary MSc programme offered by CEPMLP is unique in its content, design and delivery. It ensures a global understanding of the energy sector and its vital challenges from an economic perspective enriched and supplemented by inputs from other fields such as law, finance and management. This programme is appropriate for economists and non-economists who intend to develop analytical, problem solving and evaluation skills to analyse real world issues facing the energy sector internationally.

Mining Programme

Unlike related post-graduate programmes in this field, the core focus of the CEPMLP Mining Programme is on a combination of legal, policy, economic and management issues related to the industry, rather than pure technical aspects. The curriculum of the programme is further enhanced by close relationships with industry, international organisations and civil society stakeholders, such as Rio Tinto plc; the International Council on Mining and Metals (ICMM); and United Nations bodies.

The programme allows for the specialised training and exposure of legal, management, and economic professionals who operate within the sector.

Our on-campus teaching and research staff are supplemented by an extensive network of adjunct faculty from the world of practice.

Distance Learning

The CEPMLP degree programmes are designed to be relevant to developments in the energy and natural resources industry sectors. We have collaborated with major companies in the energy and resource sectors to develop these programmes to equip you with the necessary skills to respond to the pressures currently affecting these sectors.

With the CEPMLP Distance Learning Programme, you have the option to gain a valuable qualification at your own pace without having to put your full time career on hold.

PhD Programme at CEPMLP

Our PhD programme adopts a deliberately multidisciplinary ethos to research and scholarship so as to prepare the new generation of analysts for the multi-faceted challenges of the natural resources industry. Doctoral research is part and parcel of overall Centre research and training activities, and most PhD research involves different aspects of the natural resources industry (energy, petroleum, and mining) from economic, legal-regulatory, and often multidisciplinary perspectives.

Reflecting the major concerns of our times, there is also growing research interest in the law and policy of renewable energy and climate change issues.

Research Excellence

CEPMLP promotes a distinctive research-oriented culture among its academic staff and senior graduate students who undertake research in natural resources and energy law and policy, combining economics, financial, legal and policy issues. In recent years, the focus of this research has shifted to the problems associated with a long term transition to a low carbon economy and potential conflicts between the current carbon dependence of society and sustainability. The broad aim of our research is to achieve originality, excellence and to stimulate informed debate

Current international research projects are in cooperation with the World Bank, the European Commission and the UK Research Councils.

Extractive Industries Source Book - In 2010, we received a US\$1 million grant for a unique study on good practice issues in the development of hydrocarbons and mining resources in capital importing countries. It required the creation of an internet-based database - the Extractive Industries Source Book - that draws together and analyses 'good practice' in key activities in the international oil, gas and mining industries. In 2015, a further grant from the World Bank has allowed a programme of updating to commence and a hard copy version will be available in 2016 - www.eisourcebook.org

Strategic Dialogue on Sustainable Raw Materials for Europe (STRADE): 2016 - 2018
STRADE addresses the long-term security and sustainability of the European raw-material supply from European and non-European countries.



Chinese National Oil Companies and the Economic Development of African Oil Producers: 2016 - 2018

This is a research project co-sponsored by the Department for International Development (DFID) of the UK government and the Economic and Social Research ouncil (ESRC), amounting to nearly £1m.

The research is being undertaken jointly by the Open University and CEPMLP.


